Residential HeatSmart Rebate Program

Incentive type: Residential Heating/Cooling Rebate Program – Residential Conservation Service and REECIP Program

Eligible Technology: Energy Star Qualified AHRI installations of Ductless Electric Heat Pumps, Electric/Air Source/Geo-Thermal Heat Pumps by HeatSmart Participants.

Applicable Sector: Residential – Primary Residence Only. Not open to builders or landlords.

Incentive Amount: Account credit of 50% of the project cost up to \$1000.

Maximum Incentive: \$1000 per customer, per calendar year

Program Budget: Limited and capped

Restrictions: Only installations for Heat Smart participants who are HLPD residential customers in their primary residence serviced by the Hudson Light and Power Department. Subject to applicable restrictions in the HLPD Rate Schedules and prior agreements. The deadline to apply for an installation made during the calendar year is the last working day of January in the following calendar year.

Summary: HLPD offers residential customers financial incentives to replace inefficient heating and cooling with energy saving products. HeatSmart Customers will be required to file a copy of their contract and HeatSmart Participation Verification to reserve funds. Due to limited availability of funds, we encourage participants to file to reserve funds as soon as possible. Once the project is complete, HeatSmart Customers must provide the original receipt, proof of installation in the customer's primary residence serviced by the HLPD and the AHRI certificate supplied by the installer.
