Required Documents & Application

Directions



(1) Provide copies of:

- (a) Charger receipt. For online orders, shipping address must match the address linked with the HLPD account number.
- (b) Installation invoice from licensed electrician. If no installation was required, an onsite inspection is required to verify the equipment's use at the HPLD account address listed on the application
- (c) Vehicle registration. Address must match address associated with the HLPD account listed on this application. If the name on registration doesn't match the accountholder name, the accountholder must sign the permission signature section on page 2.

(2) Account holder signatures: sign both the acknowledgement signature and the permission signature.

Program Eligibility

To be eligible for the HLPD's EV Smart (Wi-Fi Capable) Level 2 Charger Rebate:

- (1) Customers must have an active, residential electric account with HLPD. Account must be for at least 6 months old and have a zero balance (with no arrears) for at least 6 months.
- (2) Offer limited to ONE Smart (Wi-Fi Capable) Level 2 Charger rebate per household.
- (3) Smart (Wi-Fi Capable) Level 2 Charger must be installed at the account location.
- (4) Smart (Wi-Fi Capable) Level 2 Charger must be purchased after October 16, 2019.
